

INTRODUCTION

12 & 12, Inc.'s *Bryce House* is committed to providing a sober living environment for homeless veterans in recovery from drug/alcohol abuse. *Bryce House* is possible through a generous matching capital grant with the Department of Veterans Affairs Homeless Providers Grant. Facility operations are partially funded through the VA's Grant Per Diem (GPD) program.

This unique program is one answer for veterans who are homeless and have struggled with addictions, but are now motivated to end this condition. The primary goal and focus of all treatment is to end homelessness through a structured, goal-oriented program provided through transitional housing.

A care plan is designed for each applicant to end homelessness and is individualized to meet personal needs. Primary treatment is provided by 12 & 12, Inc., with encouraged treatment at the VAMC.

ADMISSION CRITERIA

For admission to *Bryce House*, an applicant must...

1. Applicant must have 30 days of sobriety.
2. Verified veteran status.
3. Applicant must be able to work, attend school and/or volunteer in the community.
4. Applicant must be stable if on psychotropic medications.
5. This program cannot be used for temporary housing while an applicant is waiting for placement in another program or domiciliary.
6. The applicant must not be a danger to themselves or others.
7. This facility is for male occupants only. (Female veteran referred to HCHV program.)
8. Applicants will be subject to rent payment which should not exceed 30% of income or the set cap. (Unless qualified for an exemption.)

RESIDENT GUIDELINES

Documented Sobriety: You are required to have 30 days documented sobriety before you are eligible to apply. If you are currently in a treatment program, treatment staff can provide verification of sobriety.

Maintain Sobriety: If you use illegal drugs and/or drink alcohol while in the program, you will be discharged.

Actively Seek an Income: If you are not disabled, you will be expected to find employment. If you are disabled, you will be expected to have a clear plan on how you will obtain an adequate income to live independently. Your plan will be expected to be realistic and in a reasonable timeframe. If you are disabled, you are expected to develop a plan to encourage activity, either through treatment, volunteer work, and/or education.

Required Savings: If you enter the program with an income, or once you obtain an income, you will be asked to set a savings goal which will be reviewed monthly with staff.

You are expected to comply with rules and regulations while living in this facility. If the facility determines you are not complying with their rules, they can make the decision to discharge you from the program.

In order to be successful, you must be committed to meeting the goals in your treatment plan. Passes should be granted for therapeutic reasons only. The Grant and Per Diem Program's national policy identifies only three admissions in a lifetime, therefore your

commitment is encouraged and your opportunity to use this program is limited. The guidelines encourage you to be on site and actively participating in your treatment to end your homelessness. The VA liaison, Melanie Goldman, will meet with *Bryce House* staff regularly to monitor your progress in the program.

BRYCE HOUSE

Bryce House was named after long time Tulsa resident and business man, Walter Bryce whose distinctions include being a Marine Corps Captain, who served during World War II. While serving in the South Pacific, he flew a F4U Corsair fighter aircraft and was awarded the Air Medal. Mr. Bryce is one of the original founders of 12 & 12, Inc. and helped to make *Bryce House* a successful treatment facility for men in recovery.
